1. All display material is the responsibility of the exhibitor.
 2. Exhibitor assumes All responsibility for loss, thief, or damaged items.
 3. Exhibitor can unload and set up from 6:30 a.m. to 8:00 a.m. on Saturday, May 14, 2016. Exhibitor's vehicles must be out of the downtown area by 8:00 a.m. No exhibits may be removed before 4:00 p.m. on Saturday, May 14, 2016.
 4. Early Booth rental for food vender is \$75.00 per space, if application is in by May 6, 2016. We will take applications until May 11, 2016 for \$85.00 per space.
 5. If you need electric for your space the cost will be \$85.00 if in by May 6, 2016 and \$95.00 until May11, 2016.
 6. This is an outside show. There is no guarantee for weather. **NO REFUNDS GIVEN, NO EXCEPTIONS!**
 7. Exhibitors will be responsible for all booth structures, set-up, furnishings, and tear-down.
 8. Placement of booths will be at the discretion of the Committee.
 9. No recorded music will be allowed in booth areas.
 10. No exclusive rights for the sale of any item will be guaranteed.
 11. No participant will be allowed to set up without a signed/dated application and liability release.
 12. Your canceled check will be your confirmation of acceptance. **NO REFUNDS.**
 13. Committee reserves the right to determine whether goods are appropriate for event.
 14. Further instructions will be mailed to all applicants prior to show.
 15. **NO ALCOHOL MAY BE SERVED.** This is a family event!
 16. Exhibitors are responsible for the cleaning of the space before leaving.
 17. Oklahoma Tax Commission laws have changed so we will need a copy of your sales tax number. If you do not have a number you will be supplied with appropriate paper work to complete. You will be given the proper form at the event if you do not have a sales tax number.
